Furnishing of any linen napkins, coverings and/or decorations for tables except for the covering of the serving table and the coffee/milk table, which is a disposable plastic. The covering of all other tables is the responsibility of the acceptor of this contract. 3.) Any additional hall charges required by us to be paid. This will be added to your bill.

- **While we can understand that not all meals may start at the exact time stated, it is understood that if we have to wait to start to serve longer than 30 minutes after that stated time, you will incur an additional cost of \$75.00/half hour of delay. We do understand there are somethings out of your control and it will be to our discretion if the additional charge is incurred.

A \$500.00 down payment is required within seven days of the receipt of this contract to secure your date. The \$500.00 deposit is non-refundable. One half of the amount is due fourteen (14) days prior to your date along with the exact count of people attending your event. The remaining balance is due five days prior to the date of your event. Deposit is deducted off final payment. ***The exact cost of the meal is based upon the count you furnish to us fourteen(14) days prior to the date. If the number of people served exceeds your furnished number, you will be charged for the additional people.

Leftover Policy: It is the policy of *Rubicon Katering & Sausage Haus, Inc.* to give to its customer’s any reasonable amount of leftovers. We do not guarantee any amount of leftovers. However, if you desire to receive your leftovers, regardless of the amount, a container fee of \$30.00 will be added to your bill. This amount is non-negotiable. All leftover’s must be picked up during regular business hours –or- on the days we are closed at a mutually agreed upon time. During the days we are closed we will only wait 15 minutes beyond the agreed time after that time we cannot guarantee someone will be available. Please check the appropriate box;

- Upgrade C:** Glass dinner plate and coffee cups with silverware knife and fork. No water goblets and no linens..... ADD \$3.90/plate
